Questions must be in made writing addressed to the secretary and be received on or before Thursday 4<sup>th</sup> December.

Rule 13 of the Rules governing the Archerfield Airport Chamber of Commerce Inc. requires that *“At each annual general meeting of the association, the members of the management committee must retire from office, but are eligible, on nomination, for re-election.”*

The Management Committee currently consists of five positions, the persons currently in office being: Lindsay Snell - President, David McGrath – Vice President, Desmond Harrison – Treasurer, Clement Grehan – Secretary, Ross Steele Executive Officer.

Rule 14 of the Rules governing the Archerfield Airport Chamber of Commerce Inc. requires that

*(1) A member of the management committee may only be elected as follows--*

*(a) any 2 members of the association may nominate another member (the “**candidate**”) to serve as a member of the management committee;*

*(b) the nomination must be--*

*(i) in writing; and*

*(ii) signed by the candidate and the members who nominated him or her; and*

*(iii) given to the secretary at least 14 days before the annual general meeting at which the election is to be held;*

*(c) each member present at the annual general meeting may vote for any number of candidates not more than the number of vacancies;*

*(d) if, at the start of the meeting, there are not enough candidates nominated, nominations may be taken from the floor of the meeting.*

*(2) A list of the candidates' names in alphabetical order, with the names of the members who nominated each candidate, must be posted in a conspicuous place in the office or usual place of meeting of the association for at least 7 days immediately preceding the annual general meeting.*

*(3) If required by the management committee, balloting lists must be prepared containing the names of the candidates in alphabetical order.*

The Committee advises that nominations for positions will be posted on the Chamber's Website at [www.aacci.org.au](http://www.aacci.org.au) by Monday 1st December 2008.
